To consider and, if thought fit, to pass with or without modification, the following resolution as an **Special Resolution:**

"RESOLVED THAT pursuant to the provisions of Sections 196, 197, 203 and other applicable provisions, if any, of the Companies Act, 2013 (the Act) read with Schedule V to the Act and the Rules made there under, as amended from time to time and based on the recommendation of Nomination and Remuneration Committee, Board of Directors, the consent of the Company be and is hereby accorded for change in designation of Shri Subodh Chandra from Additional Director to Whole Time Director of the Company for a period of 5 (Five) years from December 17, 2024 to December 16, 2029 on the terms and conditions as to remuneration and perquisites as mentioned below.

- 1. Salary Rs. 75,000/- per month
- 2. Company's contribution to the provident fund as per Company's Rules subject to the maximum of 12% of the salary, as laid down under Income Tax rules.
- 3. Gratuity at the rate of one half months salary for each completed year of service, subject to the maximum as per rules.
- 4. The Company will provide a car to the Whole Time Director for official use. The expenses on repairs, maintenance and running paid by the Whole time Director will be reimbursed by the Company.
- 5. Reimbursement of medical expenses including hospital benefits for the treatment of self and family up to maximum of one month's salary for each completed year of service or five months salary, during five years service.
- 6. The Company will pay the fixed rental charges of telephone for residence and will reimburse cost of telephone calls for Companies Business.

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT 2013

ITEM NO. 1

The Board of the Company had appointed Shri Subodh Chandra in the Board meeting held on 17.12.2024 as Additional Director and to further designate him as Whole time Director in the General Meeting of the Company.

Now the Company wants to change the designation of Shri Subodh Chandra from Additional Director to Whole time Director (Executive Director) of the Company for smooth functioning and progress of the Company.

The Board has, based on the recommendation of the Nomination and Remuneration Committee and subject to the approval of the Members, approved the change in Designation of Shri Subodh Chandra as the Whole Time Director of the Company, for a period of 5 (five) years i.e. with effect from December 17, 2024 till December 16, 2029. If a proxy is proposed to be appointed by a Member holding more than 10% of the total share capital of the Company carrying voting rights, then such proxy shall not act as a proxy for any other person or shareholder.
- **2.** Corporate Members intending to send their authorized representatives to attend the meeting are requested to send to the Company, a certified copy of the Board Resolution authorizing their representative to attend and vote in their behalf at the Meeting.
- **3.** In case of joint holder attending the Meeting, only such joint holder who is higher in the order of names will be entitled to vote.
